

# Website privacy statement

Protecting your privacy when processing personal data and safeguarding all commercial data is important to us. When you visit our website, we treat the collected personal data as confidential and, of course, in accordance with statutory regulations.

### Collecting and processing data

When you visit our web pages, our web server saves the IP address of your Internet Service Provider by default. We also register the web page from which you arrived at our page, the date and duration of your visit and the type of Internet browser and operating system you are using. We use this data for statistical purposes, to diagnose server problems and to improve our Internet service.

#### This website uses Google Analytics

Google Analytics – a web analytics service from Google Inc. ("Google") – uses what are known as cookies, that is, text files that are stored on your computer and enable an analysis of your use of the website. The information generated by the cookie regarding your use of this website (including your IP address, which is, however, anonymised before being saved using the "anonymizelp" method so that it can no longer be traced back to you) is transferred to a Google server in the USA and saved there.

Google will use this information to evaluate your use of the website, compile reports about website activities for the website operator and provide further services relating to the use of the website and the Internet. Google may also forward this information to third parties insofar as this is prescribed by law or if said third parties are to process the data on behalf of Google. Google will under no circumstances associate your IP address with other Google data.

#### **Use of Siteimprove Analytics**

This website uses Siteimprove Analytics, a web analytics service provided by Siteimprove GmbH. Siteimprove Analytics uses "cookies", which are text files placed on your computer, to enable analysis of website use. ## Use of Google reCAPTCHA

To protect its orders via internet form, the Kaeser Kompressoren SE uses the Google Inc. (Google) reCAP-TCHA service. The query is used to distinguish whether input is made by a human or improperly by means of automated machine processing. The query includes sending the IP address to Google along with any other data that Google may require for the reCAPTCHA service. For this purpose, your input will be transmitted to Google and used there. By using reCAPTCHA, you agree that the recognition input you provide will be used for the digitisation of old texts and works.
